9:30 Monday

Banner Boot Camp I (G).....Donna Hayden (ASU)

This session, targeting new Banner users, will review different search and navigation methods, the quickflow process, general user's preferences, enterprise pin preference, and protection of sensitive data (masking).

Employee Self-Service (H).....Rita Singleton (JSU)

The attendees will understand the basics of using the Employee Self-Service application. Attendees will how employees view, update, and print records from the Human Resources database using Web technology. Hypertext capabilities provide easy navigation through the Employee Self-Service Web pages.

Many Finance Banner users can relate to the challenge of developing user friendly reports. In this session presenter will share tips and reports created through the use of Access.

The Banner XE Student Experience (S).....Ed Hauser (Ellucian)

This session takes a deeper look at the Banner Student XE modules (Course Catalog and Schedule of Classes, Faculty Grade Entry, Attendance Tracking and Event Management) that have been released to date. Banner Student XE provides architectural, functional, and usability improvements to both Administrative Banner and Self-Service Banner with the initial focus on the student, advisor, and faculty persona. We'll discuss customer adoption and provide a glimpse of Banner XE projects in progress such as student registration and some common components.

Using Holds to Require Orientation (S,T).....Allen Coleman, Steven West (ICC)

This session will look at how Itawamba Community College used a Banner hold to require freshmen to attend orientation. We'll discuss how ICC automated the adding and removing of the hold and briefly describe the technical details we used, while emphasizing areas were other schools could be creative and automate the process in their own way.

SQL and PL/SQL are two languages used to extract information from Banner databases. In this session we'll discuss the basics of both of these and learn how to use them to create simple queries as well as more detailed reports for both on and off campus clients.

It is designed to accommodate efficient approval signature processing for Human Resource Payroll operations and supports the movement of a paperless office. An EPAF, accessed within Banner Online Services, is an electronic venue to process employment actions that would apply information to the NBAJOBS, PPAIDEN and/or PEAEMPL forms. The forms and reports were developed to enter certain actions for approval, define the necessary approval hierarchy, track items through the approval process, and to provide an audit trail of approval/disapproval history.

Discussion of the administration and setup required when using the ARGOS reporting tool.
